CBR, Inc. agrees to furnish all labor, supervision, materials, and scaffold equipment; to carry Workman's Compensation, Public Liability and Property Damage Insurance; and use every reasonable precaution to protect the public and any adjacent property during the performance of the following work.

Extent of work: Power washing, applying sealer.

 North, West, East, and South elevations from floors one to four will have impregnating sealer applied to all precast concrete, per manufacturer's specifications. This shall include power washing all walls to be sealed. Sealer to be used shall be BSM 400.

Cost of Labor and Materials:

South, West, and North elevations from floors four to twelve will have impregnating sealer applied to all precast concrete, per manufacturer's specifications. This shall include power washing all walls to be sealed. Sealer to be used shall be BSM 400.

Cost of Labor and Materials:

Cost of Mobilization, Demobilization, and Clean Up: (This includes the set up of the canopy and the swing stage as well as swing stage relocation.)

Inspect the North, South, and West elevations from the swing stage to identify areas of failed concrete. Properly clean, prep, prime, paint, and patch the concrete to match existing color.
Cost of Labor and Materials per Square Foot of Patch Area: \$250.00
The price does not include cost of Permits.
TERMS: We require a 30% deposit and signed proposal prior to our scheduling or proceeding with any project. Progress and final payments are due within seven days of receipt of invoice. Final payment is due upon competition of work. CBR, Inc. reserves the option to cease work if payments are not received within the time specified.
